

Guide to using the Fi360 Fiduciary Score® in communications and marketing by third-party licensees

PRESENTATION OF FI360 FIDUCIARY SCORE® DATA

In every instance, the Score must be presented with the following information:


- **1.** The name of the investment, along with share class and ticker symbol, if available
- 2. The peer group (aka Morningstar Category) of the investment
- **3.** The numerical value of the Fi360 Fiduciary Score® for the investment
- **4.** The number of peers within the peer group of the investment

GRAPHICAL EXPRESSION


It is preferred, but optional to include a graphic as part of the Score's presentation. If a graphic is included, it must have the look and feel of the graphics shown in the examples below. Vertically- oriented graphics will place the lower number at the top of the graphic bar chart, and horizontally oriented graphics will place the lower number to the left of the graphic bar chart. The Score will be identified on the graphic according to its relative position in the peer group. A diamond marker on the graphic will be used to identify the position of the investment within the graphic. Please see Examples 1 and 2 at the end of this guide for additional reference.

USING THE GRAPHIC


Whenever the graphical expression is used, the color coding shown below must be used to identify the placement of the investment within a quartile according to the numerical value of the Fi360 Fiduciary Score[®].

DESCRIPTION

For each discrete document on which the Score appears, a description of the Score must be included.

Description: The Fi360 Fiduciary Score® is a peer percentile ranking of an investment against a set of quantitative due diligence criteria selected to reflect prudent fiduciary management. The Fi360 Fiduciary Score® Average is a one-, three-, five-, or ten-year rolling average of an investment's Fi360 Fiduciary Score®. All Scores are color coded based on the quartile they fall in (1st - Green; 2nd - Light Green; 3rd - Yellow; 4th - Red). EXTENDED PERFORMANCE

Extended performance data may be used to calculate the Fi360 Fiduciary Score®. Extended performance is a return estimate based on the performance of the investment's oldest share class, adjusted for fees. Data points that may be calculated with extended performance data include trailing returns and MPT statistics.




APPROVAL OF COMMUNICATIONS AND MATERIALS BY BROADRIDGE


